Wentworth Healthcare Limited, provider of the Nepean Blue Mountains Primary Health Network (NBMPHN) is a not-for-profit organisation which works to improve health for the people in our community. This includes the Blue Mountains, Hawkesbury, Lithgow, and Penrith local government areas.

Our mission is to empower general practice and other healthcare professionals to deliver high-quality, accessible, and integrated primary healthcare that meets the needs of our community.

### 1. Primary Purpose of This Role

The *Program Development Officer* will be part of the Healthy Ageing and Palliative Care project team. This project role involves supporting both Residential Aged Care Homes (RACHs) and commissioning activities that support those ageing in the community setting across the Nepean Blue Mountains region. The role will contribute to the implementation of a range of initiatives that facilitate more timely access to primary health care professionals, improving the management of chronic conditions and reducing the need for hospitalisation where it can be avoided. This role will assist with the development of activities that support healthy ageing and older people to live at home longer.

The position will develop and maintain relationships across the aged care sector, including RACHs, primary care, allied health professionals, the local health district, NGOs and digital health agencies. A critical component of the role will be the development and management of stakeholder relationships and prioritising competing needs to achieve desired outcomes.

Specifically, this role will:

- Contribute to commissioning healthy ageing strategies and initiatives for vulnerable population groups including people with complex chronic diseases.
- Support RACHs across a range of programs to build their capacity to enhance support for their residents and ensure access to primary care to ensure continuity of care.
- Contribute to the commissioning of primary health care providers to provide care to residents in RACHs where availability of a primary care workforce is limited.

## 2. Key Outcomes

2.1. Relationships with key stakeholders are developed and managed to ensure ongoing engagement and collaboration to meet the objectives of the Healthy Ageing Strategy.

- 2.2. Operational processes that support management and coordination of projects will be developed, implemented, and monitored in conjunction with our staff.
- 2.3. RACHs are supported to increase the availability and access to primary health care support for residents including digital health (My Health Record), and MyMedicare (voluntary patient registration).
- 2.4. Improved access to, and support for older people to engage with healthy ageing initiatives that better manage their chronic health conditions.
- 2.5. Capacity building activities including education and training are coordinated and delivered across primary health care and aged care settings to improve awareness of healthy ageing initiatives and increase the capability of residential aged care staff.
- 2.6. Key stakeholder relationship and engagement activities are undertaken in a professional manner and underpin the scoping and maintenance of new and existing initiatives and opportunities.
- 2.7. Projects and initiatives will be implemented, coordinated, and maintained within budget and on time in accordance with contractual guidelines and Wentworth Healthcare's annual plan.
- 2.8. High-quality documents and other related communication outputs are developed.

- Proven ability to utilise information technology tools (in particular the Microsoft Office suite, customer relations databases, email, and internet) to an intermediate level.

• Demonstrated knowledge and experience working with primary health care providers including General Practitioners, Nurse Practitioners and Allied Health Providers.
